



## Proposed Permit Fee Schedule

Effective 3-19-2019

### Driveways

Residential Driveway (1-2 homes)	\$50	(includes approving use of existing drive)
Farm Field Approach or Logging Access	\$50	
Multi-residential (3-4 homes)	\$100	
All other Multi-residential, Commercial Drives or New Public Road Approach	\$200	
Temporary Construction Driveway Approach	\$150	

For commercial and multi-residential driveways where HMA paved surface and/or concrete curb & gutter are required by the Road Commission, a \$6,000 escrow deposit is required to guarantee completion of HMA surface paving. Financial surety in the form of a Bond, Cash Bond, or Bank Irrevocable Standby Letter of Credit is acceptable, provided the Road Commission's format is used.

Applications filed after work has been started 3 times fee

Overhead Utility Installation with new poles	\$200
Underground Utility Installation	\$200
Underground Utility Service Connection	\$125

Open Cut Road Crossings	\$250
Bore Road Crossings	\$150
Electric Utility Seasonal Truck Permit	\$100 per truck per season

**Miscellaneous Fees**

Any work done before permit is issued	3 times fee
Commercial Driveway/Private Road Site Plan Review	\$500

Staff, crew or outside services required (in the opinion of the Road Commission) for attendance at meetings, plan review & analysis, inspection of work, testing, event preparation, cleanup, etc. is to be based on labor and fringe benefit rates, equipment rental rates and outside services charges for the time required to accomplish those tasks.

Staff will give an estimate of the total fee to the applicant before review process has begun.

Fee for preliminary work to be calculated and paid prior to the permit being issued. Inspection, testing and post-permit work to be calculated and paid promptly upon completion of the work. Improvements may not be put into use until all fees have been paid.
